Forms and timeline to go to the community by Friday September 22nd, 2023.

Monday July 31, 2023	Cutoff date for membership to be eligible to vote.
Monday Oct. 16, 2023,	Last date for Election Committee to receive nominations.
Sunday Oct. 22, 2023,	Verify candidates' membership with Membership Committee
Sunday Oct. 29, 2023,	Last date for candidates to withdraw from election and Last date for candidates to submit their photographs along with a brief biodata & personal statement (not exceeding 80 words) about their IAGD BOD candidacy
Saturday Nov. 4, 2023,	Candidates will be introduced to the Community at the IAGD November monthly dinner
Monday Nov. 6, 2023,	Ballots will be mailed to eligible members, along with candidates photograph and personal statements.
Friday Nov. 24, 2023,	Last date (post marked) to receive ballots.
Friday Dec. 1, 2023,	Ballots will be counted at IAGD
Saturday Dec. 2, 2023,	Election results will be announced at the IAGD December Monthly Dinner and General Body Meeting

- The nominations must be submitted using the Nomination Form, properly filled out with required signatures of IAGD Members.
