NIKKAH APPLICATION FORM

Rules & Regulations for Nikkah in Prayer Area

- The host understands that the masjid is **not being rented out**
- The host understands that the **time** allowed for nikkah is 15-30 mins (**max 30 mins**) in the prayer area. Any setup of a flower curtain/divider must be done in banquet hall or new basement for 2 hr. duration including the 15-30 mins of nikkah time (if time goes over 2 hours, there will be \$100 charge per hour.) Up to 50 guests, no charge (no round tables/lunch or dinner in this free time) For guests over 50 in number, it is **\$3** per chair.
- Regular chairs will be provided; any specific settings/arrangements are at the cost of the host.
- The nikkah is not permitted during any prayer time
- A security deposit (\$2000) is required for the Nikkah. This will be refunded if the rules are not violated.
- Absolutely no food or drinks in prayer area/lobby area; if host is interested in hosting lunch or dinner, the banquet hall must be rented; separate fees/charges apply. Please ask for banquet hall application
- No rearrangement of chairs in prayer area unless it is to accommodate elders who are unable to sit on the floor; host and their family must put chairs back how they found them when nikkah is done
- Absolutely **NO decorations of any kind in the prayer halls**. i.e. No sofas, carpet, candles, gift boxes, flower curtains, stools, real flowers allowed in the prayer area.
- Women are strongly encouraged to use women's prayer hall. However, women are allowed in mens prayer hall but with **proper attire and seated in the back of the hall**.
- **No inappropriate shows of affection**
- Photography is permitted. But No excessive photography, No drones, No camara carts allowed.
- Full Payment and security deposit must be received at least 4 weeks prior to preferred date of nikkah
- Cancellation of Nikkah (within 30 days of event:) \$100 charge (No refunds for nikkah for changes within 7 days of event. Full nikkah payment will not be returned).
- Changes made for Nikkah: \$50 charge per change. i.e. date change=1 change; time change=1 change
Below charges cover **15-30 min nikkah time in prayer area + 1.5 hr. refreshment accommodation in social hall up to 50 guests only**
